

PUBLIC NOTICE OF INTENT TO AWARD AGREEMENTS

Pursuant to the Call for Applications for the Auction or Sale of Big Game Fundraising License Tags for the 2024-25 Hunting Season

Following the bid opening on October 16, 2023, an evaluation and review for responsiveness to the Call for Applications and scoring and ranking responsive applicants, the California Department of Fish and Wildlife proposes to award agreements for the auction or sale of big game fundraising license tags to the organizations listed below. At this time, it is anticipated that 2 bighorn sheep, 3 elk, 2 pronghorn, and 9 deer tags will be awarded. All fundraising license tags will be available contingent upon adoption of regulations authorizing such tags. Should additional fundraising tags become available, pending completion of wildlife surveys and data analyses, an organization shall be awarded the tag from the existing list of responsive applicants.
