### **Waterfowl and Upland Game Bird Hunting**

#### **SEPTEMBER 1**

- ✓ **Dove Season Opens Statewide** (see page two for dove regulations and bird hunting validation guide)
- ✓ Waterfowl Reservation Drawing Applications become available (located under 2022 Hunting, Drawing Tab)

#### **How to Apply for Reservations to Hunt Waterfowl**

Reservation to hunt waterfowl on State-operated wildlife areas are issued by random drawings for Type-A wildlife areas and for opening day on some Type-B wildlife areas.

Applicants may use a combination of the following applications to apply for reservations:

- Multi Choice Application allows an applicant to select individual hunt dates for one or more wildlife areas throughout the season.
- Season Long Application allows an applicant to apply for every available Saturday, Sunday, and/or Wednesday hunt date for one or more wildlife areas for the entire season.
- Military and Veteran Weekend Application allows an active military personnel or veteran to apply for available military-only waterfowl hunts at participating stateoperated wildlife areas.

**Disabled Accessible Hunting Sites:** Customers applying for disabled accessible hunting sites must use the Multi Choice and/or Season Long **Mobility Impaired Drawing Application(s).** Please make sure the correct version of the application is selected for your customers.



Applicants must apply **17 days prior to the hunt date**; if the hunt date does not appear on the application selection screen, at the time of applying, the deadline for that specific hunt date has passed.

#### **Waterfowl Reservation Drawing Results**

Successful applicants are mailed a Waterfowl Reservation Notice and will receive an email notification if they opted-in to electronic notifications from CDFW. Results are posted online at least seven days prior to each hunt day. All applicants can view their pending hunt choices, drawing results, and print drawing notices online by logging on to the CDFW's Online License Sales and Services website at <a href="https://www.ca.wildlifelicense.com/InternetSales/">www.ca.wildlifelicense.com/InternetSales/</a>.

#### Wildlife Area Passes - Required on Type A and Type B Wildlife Areas

To hunt on a Type A or Type B wildlife area, hunters must have one of the following Wildlife Area (WLA) Hunting Passes:

- Type-A One-Day Pass: valid for one day on a Type-A WLA.
- Type-A Two-Day Pass: valid for two days or two people for one day on Type-A WI A.
- Type-A Season Pass: valid for the entire season on all Type-A and Type-B WLAs.
- Type-B Season Pass: valid for the entire season on Type-B WLAs.

Junior hunting license holders are exempt from the Wildlife Area Pass Requirement.

#### **CUSTOMER IDENTITY REMINDER**

License agents can add customer identification to a new or existing profile. The following are acceptable forms of identification (ID):

- State ID (Driver's License or ID Card)
- Birth Certificate
- Passport
- Military ID
- Green Card (Permanent Resident Card)
- Foreign Government Issued Photo ID
  - American Indian Tribal ID (Listed under Foreign IDs)

#### **NEW DUPLICATE SALES PROCESS**

A customer may now select to duplicate the individual items that were included on their original license purchase. The location to sell a duplicate item has been moved to a button at the bottom of the sales catalog on the CDFW sales terminal.

#### **HUNTER EDUCATION REMINDER**

To purchase a hunting license, a customer must have on file or present a valid form of hunter education listed below:

- California Hunter Education Certificate
- Out of State Hunter Education Certificate
- Previous California Hunting License
- Out of State Hunting License (issued within the last two vears)
- Online California Hunter Education Certificate

#### SPINY LOBSTER REPORT CARDS AVAILABLE AUGUST 15

Customers that failed to report their 2021/2022 Spiny Lobster Report Card by the April 30 deadline will have a \$21.60 Non-Reporting Fee added to their purchase of a 2022/2023 Spiny Lobster Report Card. The 2022/2023 Spiny Lobster season opens at 6:00 am on Saturday, October 1 and goes through Wednesday, March 22.

Species	Area	Season Dates	Daily Bag Limit	Possession Limit
Mourning Dove and White-winged Dove	Statewide	September 1 – 15 and November 12 - December 26	15, up to 10 of which may be white-winged doves	Triple the daily bag
Spotted Dove and Ringed Turtle Dove	Statewide	September 1 – 15 and November 12 - December 26	No limit	No limit
Eurasian Collared-Dove	Statewide	All Year	No limit	No limit

\*\* A Federal Duck Stamp is required for anyone 16 years of age or older and are not sold through CDFW.
