What is a California marine protected area (or "MPA")?


An MPA is a type of managed area whose main purpose is to protect or conserve marine life and habitats in ocean or estuarine waters. California's MPA Network consists of 124 areas with varying levels of protection and 14 special closures, all designed to help safeguard the state's marine ecosystems. Most marine conservation areas such as Pyramid Point State Marine Conservation Area provide some opportunity for commercial and/or recreational take (species and gear exceptions vary by location - see reverse).

One goal for California's MPAs was to strategically place them near each other to form an interconnected network that would help to preserve the flow of life between marine ecosystems. Within that network each MPA has unique goals and regulations, and non-consumptive activities, permitted scientific research, monitoring, and educational pursuits may be allowed.

Why was this location chosen for a state marine conservation area?

One of the goals for Pyramid Point State Marine Conservation Area is to protect the sandy beach, rocky shore, offshore rocks, and soft seafloor habitat found there. Large offshore rocks support Aleutian Canada geese and breeding seabirds, including some of California's only breeding forktailed storm petrels and tufted puffins, and large rookeries of great blue herons, black-crowned night herons, and snowy egrets (farthest north in the western U.S.). Shallow rocky reef habitat is used by a variety of fish, including nearshore rockfish species. This MPA also provides nearly 14 square miles of protected forage habitat for marine mammals such as Steller's sea lions.

Placing a state marine conservation area here provides moderately high levels of protection for marine life and the habitats they use.



Pyramid Point State Marine Conservation Area Boundaries and Regulations *from* California Code of Regulations Title 14, Section 632

Boundary:

This area is bounded by the mean high tide line and straight lines connecting the following points in the order listed except where noted:


42° 00.000' N. lat. 124° 12.735' W. long. (1), 42° 00.000' N. lat. 124° 19.814' W. long. (2), thence southward along the three nautical mile offshore boundary to 41° 57.500' N. lat. 124° 17.101' W. long. (3) and 41° 57.500' N. lat. 124° 12.423' W. long. (4)

Permitted/Prohibited Uses:

- 1. It is unlawful to injure, damage, take, or possess any living, geological, or cultural marine resource for recreational and/or commercial purposes, with the following specified exceptions:
 - **a.** The recreational take of surf smelt by dip net or Hawaiian-type throw net is allowed.
 - **b.** The following federally recognized tribe is exempt from the area and take regulations for Pyramid Point State Marine Conservation Area and shall comply with all other existing regulations and statutes:

 Tolowa Dee-ni' Nation [previously the Smith River Rancheria].





Take may be authorized for research, restoration, and monitoring purposes under a scientific collecting permit. See California Code of Regulations Title 14, Section 632(a).
